 - 4. Loretta Lacey Award: received 5 nominations, recipient of this year's award is Wendy Hellerstedt
 - B. Education (Elizabeth Gulitz)
 - 1. Afternoon session today will be on Case Studies
 - a. MCH instructors getting more involved with case studies, putting them on websites
 - b. We will be looking for funding opportunities to develop this project more fully, possibly the MCH Bureau
 - c. Suggestions for use of Case Studies include how to develop and use them, attaching MCH competencies to them; strong potential for involving other disciplines as well (epidemiology, social work, research)
 - d. Please offer other ideas to E. Gulitz or K. Ramiah
 - C. Research (Edith Kieffer/ Karen Peterson)
 - 1. Had originally planned Fall (2004) APHA meeting for funding agencies, but has now changed this topic to Case Studies (see above); Spring (2005) meeting will be with the funding agencies
 - 2. Implementation issues on community-based programs
 - a. specific challenges on funding and planning community-based projects; how to build collaboration and relationships, etc.
 - b. Discussion about this topic:
 - 1. the focus should be integrated between researchers, community partners, and then get into evidence-based implementation issues
 - 3. Other topics related to research issues:
 - a. "Pre- and Post-Award Blues" – perhaps have a workshop on this topic
 - b. ATMCH table – we should have a booth at APHA/AMCHP with all of our stuff on it

- c. We have a better relationship with AMCHP – it costs \$2500 to become a sponsor of AMCHP
- d. Also, review of abstracts for AMCHP conference previously done by some ATMCH members
- 4. Student Research Symposium
 - a. Discussion of how many abstracts were submitted, were any of them funded, and should we give some kind of stipend (\$250) to the student(s) whose abstract was selected (no conclusion to this discussion)
- 5. Faculty-Membership Activity in memory of Sheila Smythe
 - a. Nothing officially has been done yet about this issue
 - b. Should we name this Faculty-Membership Activity after her?
 - c. Should we re-think this, as there is no constituency
 - d. Motion made to table this discussion, and at least do an In Memoriam for her in the ATMCH Newsletter
 - e. Take this topic back to the Executive Committee to make a decision
 - f. Perhaps ATMCH should make a donation to her school

 - 1. Second Mentoring Project has been identified, but not yet scheduled
 - 2. Review of materials developed last year by E. Declercq for New Jersey

 - 1. 22 people will be attending this session; mostly students, but some faculty from isolated programs
